### **Parent and Family Engagement Policy**

#### PART I. GENERAL EXPECTATIONS

Silas Wood Sixth Grade Center agrees to implement the following statutory requirements:

- Silas Wood Sixth Grade Center will put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.

# PART II. DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED DISTRICT WIDE PARENTAL INVOLVEMENT POLICY COMPONENTS

- 1. The Silas Wood Sixth Grade Center will take the following actions to involve parents in the joint development of its district wide parental involvement plan under section 1112 of the ESEA:
  - Confer with parent representatives and volunteers from school site based management teams (SBMs) and PTA members to gather parental input.
  - Conduct an annual review of the existing school wide involvement policy through feedback from parent members of the school community.
- 2. The Silas Wood Sixth Grade Center will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
  - In the event that a school is cited for improvement, the school will notify parents, with assistance from the district; whose children attend a school identified as an improvement school and will follow all the steps required by the regulations.

The Silas Wood Sixth Grade Center will build the parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
  - A. The Silas Wood Sixth Grade Center will provide assistance to parents of children in understanding topics such as the following, by undertaking the actions described in this paragraph --

    - the State's student academic achievement standards.
    - the State and local academic assessments including alternate assessments,
    - the requirements of Part A,
    - how to monitor their child's progress, and
    - how to work with educators:
      - Information will be provided to parents explaining content standards and expectations for student achievement through presentations, literature, newsletters, and parent conferences.
      - Information will be provided to parents explaining academic assessments shared during the year through presentations, literature, newsletters, and parent conferences.
      - Information concerning parent-teacher conferences and working with educators will be provided prior to scheduling conferences and will be discussed in parent meetings.
      - o Information will be provided to parents describing Title I requirements and activities and programs at their child's school.
  - B. The Silas Wood Sixth Grade Center will provide materials and training, with the assistance from the district, to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
    - The school will support on-going parent involvement in activities by encouraging use of available resources via online, e.g. Compass Learning.
    - The school will offer various workshops/classes to improve student achievement:
      - o Annual Curriculum Nights
      - o Updating information on the school's webpage
      - Annual ENL parent nights will be held, wherein parents of ELLs are provided with information about how to support their child's language and academic development.

- C. The Silas Wood Sixth Grade Center will, with the assistance of its district and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - The school will confer and seek advisement from PTA representatives and parent volunteers to generate ideas for ways to connect with parents.
  - Administrators and instructional leaders will seek literature and workshops on parent involvement practices through conferences and other creditable agencies.
- D. The Silas Wood Sixth Grade Center to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
  - The school will collaborate, to the extent that it is feasible and appropriate, with the district's primary centers to support parent involvement activities.
- E. Silas Wood Sixth Grade Center will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
  - The school will work with district level personnel to ensure that information related to the school and parent programs/meetings is comprehensible and available in alternative formats upon request and to the extent practicable, in a language the parents can understand.
  - Parent information and resources will be available on the school's webpage, which is accessible through the district website, www.shufsd.org.

In order to maximize parental involvement and participation in their children's education, the Silas Wood Sixth Grade Center will:
