

Stimson Middle School

Parental and Family Engagement Policy

PART I. GENERAL EXPECTATIONS

Stimson Middle School agrees to implement the following statutory requirements:

- Stimson Middle School will put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- In carrying out the Title I, Part A parental involvement requirements, to the extent practicable, Stimson Middle School will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request, and, to the extent practicable, in a language parents understand.
- The Stimson Middle School will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parental involvement is spent, and the District will ensure that not less than 95 percent of the one percent reserved goes directly to the schools.
- The Stimson Middle School will carry out programs, activities and procedures in accordance with this definition:

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—

- (A) that parents play an integral role in assisting their child's learning;*
- (B) that parents are encouraged to be actively involved in their child's education at school;*
- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*
- (D) the carrying out of other activities, such as those described in section 1118 of the ESEA.*

PART II. DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED DISTRICT WIDE PARENTAL AND FAMILY ENGAGEMENT POLICY COMPONENTS

1. The Stimson Middle School will take the following actions to involve parents in the joint development of its district wide parental involvement plan under section 1112 of the ESEA:
 - Confer with parent representatives from school site based management teams (SBMs) and PTA members to gather parental input.
 - Conduct an annual review of the existing school wide involvement policy through feedback from parent members of the school community.
2. The Stimson Middle School will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - In the event that a school is cited for improvement, the school will notify parents, with assistance from the district; whose children attend a school identified as an improvement school and will follow all the steps required by the regulations.
3. The Stimson Middle School will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs: Project Excel, VAP programs, etc.
 - Coordinating information sessions to assist transitions from middle school to high school by working with the guidance personnel to support families, i.e. selecting classes, coordinating informational sessions about college/career pathways, etc.
4. The Stimson Middle School will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental.
 - Based on parent feedback gathered from SBM teams and PTA members, each school will develop practices to address the issues identified within the involvement policies.
5. The Stimson Middle School will build the parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:

A. The Stimson Middle School will provide assistance to parents of children in understanding topics such as the following, by undertaking the actions described in this paragraph --

- the State's academic content standards,
- the State's student academic achievement standards,
- the State and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:
 - Information will be provided to parents explaining content standards and expectations for student achievement through presentations, literature, newsletters, and parent conferences.
 - Information will be provided to parents explaining academic assessments shared during the year through presentations, literature, newsletters, and parent conferences.
 - Information concerning parent-teacher conferences and working with educators will be provided prior to scheduling conferences and will be discussed in parent meetings.
 - Information will be provided to parents describing Title I requirements and activities and programs at their child's school

B. The Stimson Middle School will provide materials and training, with the assistance from the district, to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- The school will support on-going parent involvement in activities by encouraging use of available resources available via online and training parents how to use technology, e.g. Compass Learning.
- The school will offer various workshops/classes to improve student achievement:
 - Annual Curriculum Nights
 - Coordination of informational sessions to educate and support parents with helping their children complete projects for STEAM and National History Day Curriculum Fair
 - ENL Parent Workshops

C. The Stimson Middle School will, with the assistance of its district and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- The school will confer and seek advisement from PTA representatives to generate ideas for ways to connect with parents.

- Administrators and instructional leaders will seek literature and workshops on parent involvement practices through conferences and other creditable agencies.
- D. The Stimson Middle School to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
- The school will collaborate, to the extent that it is feasible and appropriate, with the district's K-6 schools to support parent involvement activities.
- E. Stimson Middle School will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
- The school will work with district level personnel to ensure that information related to the school and parent programs/meetings is comprehensible and available in alternative formats upon request and to the extent practicable, in a language the parents can understand.
 - Parent information and resources will be available on the school's webpage, which is accessible through the district website, www.shufsd.org.

PART III. DISCRETIONARY DISTRICT WIDE PARENTAL AND FAMILY ENGAGEMENT POLICY COMPONENTS

In order to maximize parental involvement and participation in their children's education, the Stimson Middle School will:

- provide necessary literacy training for parents from Title I, Part A funds, if the school district has exhausted all other reasonably available sources of funding for that training;
- arrange school meetings at a variety of times, or conducting in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend those conferences at school.
